This project is not merely another construction endeavour; it is a priority project that will define the future of UG School of Law and legal education in the country as a whole.

I am thrilled to announce that our commitment to this project is unwavering. We have set an ambitious timeline to complete the construction of the UGSoL Building Complex within two years. With support from you our distinguished alumni and friends of the University, I am confident that we will achieve this target.

Having had a sneak peek at the programmes outlined for this week-long Homecoming (starting today to Sunday, 5<sup>th</sup> November), I anticipate that they will be very exciting.
